Micro Capital Grant Assessment Process

The assessment process set out in this document will be used by the South Midlands Growth Hub to assess all Micro Capital grant applications.

Stage 1: Gateway

Applying enterprise is eligible: A sole trader/micro business or early stage business A registered enterprise Not in liquidation, dissolved, struck off or subject to a striking-off notice Is not an undertaking in difficulty Registered in the UK Has a base in the South Midlands area Plans to realise a project in the area Passes credit check A sole trader/micro business or early stage business Pass/Fail Projects must pass all of these gateway criteria to be considered for selection. Stage 3: Selection

- Projects will be provided with a combined overall score in accordance with the methodology above.
- Projects which score over the minimum threshold of 75% will be presented to the grant panel for a final decision
- Projects which then are approved by panel will be awarded in order of score until the funds allocated have been fully allocated.
